4. High School Campus Update

Mr. Yilmaz: There are some environmental and DOT issues for the prospective HS campus site. This is getting very challenging and also time and money consuming for this project. Based on the discussion we had earlier, we would like to terminate the purchase agreement with the seller. We will provide notice of Purchaser's election, pursuant to Section 4.4.1(b) of the Agreement, to terminate this Agreement prior to the expiration of the Evaluation Period (as defined in the Agreement). Pursuant to Section 3.1(c) of the Agreement, we are entitled to the immediate return of the Earnest Money (\$30,000.00). We will discuss the alternative new HS campus site at our next meeting.
