- **5. Student Successes -** Mr Rollins introduces Michael Andrade, a student from GUHS, who was selected for a Launch Greenville internship with Base360. Mr Andrade was not present at the beginning of the Student Success portion, but joined live at 6:22pm to speak on his internship.
- **6. Election Update -** Mr Cronin states that the candidate profiles from GUHS, Spartanburg, and Greenville Elementary were distributed on November 7th. The next step is the Election week of December 5th through December 9th. Each primary contact per student and staff member will receive an individual link to vote
 - Dr Haque asks if voting is only electronic?

 - a) Enrollment Update & Efforts A detailed list of things GREEN is doing to
 promote enrollment for both families and great staff members has been shared
 with the board: signs, postcards to families, powerpoint for informational
 meetings, enrollment buttons on each website, reaching out to local schools to
 build relationships with those communities, social media at each campus,
 seeking out teacher replacements, using Handshake for teachers, and updating
 our application process to be more family friendly.
 - <u>b) Growth & LOI</u> We submitted two letters of intents to the District. Both of these are replications. The first would be a K-5 targeting Taylors and the second isa K-8 targeting Simpsonville. Both of these are responding to ensuring we can have long-term viability at the high school, protecting enrollment at the Greenville Middle School, and responding to the families who are unable to receive admittance to Greenville Elementary. These LOIs are not binding. Once we

approve the High School viability in Greenville, then we can get to the high school promises made in other cities: Spartanburg, Midlands, and the lowcountry.
